The "Wrzos" Holiday Home is located in Kościelisko, in the vicinity of the Tatra Mountains National Park. The Kościeliska Valley and the Chochołowska Valley are located in its close proximity. It takes about 15 minutes to get to the towns of Zakopane and Gubałówka. Single, double, triple and quadruple rooms for with complete bathroom facilities, breakfast /buffet/ on site. Bookings for any number of days.

### **Reservation of stays for the period from 25 May to 30 November 2024 will be possible starting from 22 May 2024, at 8:00**

Price per day per person (inclusive of taxes) - paid in full:

1. **during the season** (the season is considered to be: the holiday period, i.e. from 1 July to 31 August 2024, and the Christmas and New Year period, i.e. from 21 December 2024 to 6 January 2025).

The tourist tax in accordance with the rates of the Resolution of the Kościelisko Commune Council is payable in the "Wrzos".

Parking place at the "Wrzos" costs PLN 12.30 gross per day.

#### Accommodation rules:

- Check-in day at the "Wrzos" starts from 15:00 on the arrival day and check-out should be done by 12:00 on the day of departure.
- At the beginning of a stay at the "Wrzos", a person is obliged to:
  - check in immediately upon arrival

- pay the tourist tax
- pay the parking fee (if applicable; prior notification at the Office for Personnel Social Benefits is required).
- Breakfast is served between 8:00 and 10:00 (included in the price).
- Complete smoking ban in the entire facility.
- Pets are not allowed in the facility.
- Each room is equipped with a fridge, kettle, hairdryer and towels.
- At the guests' disposal are:
  - a microwave in the lobby
  - a ski room
  - a table tennis table
  - bicycles and electric bicycles
  - an outdoor gym
  - massage mats
- Detailed rules of stay at the "Wrzos" can be found in the facility's Rules and Regulations.

**The fee for the stay must be paid by the date indicated on the invoice.**

- The reservation of those failing to pay their holiday fees on time will be cancelled.
- The reservation can be cancelled before the invoice is issued.
- In order to obtain any reimbursement in the event of a fortuitous event preventing the person's trip, which occurs after the invoice has been issued, a person should present a document confirming the situation (e.g. a medical certificate, etc.) and get the approval of the head of the Office for Personnel Social Benefit [pl.BSSOC].

**Starting from 22 May 2024, holiday allocation applications can be submitted by:**

- 1. UW employees, UW doctoral students and UW pensioners/disability pensioners currently employed at the University exclusively through completing an electronic form in the DocSense system;**
- 2. UW pensioners and disability pensioners who have terminated their employment contract with the University due to retirement/receiving disability pension in person at the UW Office for Personnel Social Benefits (Mały dziedziniec, first floor, room no. 16, between 8.00 and 15.00).**

Priority in allocation of holiday at the facility is given to :

- persons with disabilities,
- large families (having at least two children);
- UW employees working under an appointment or a permanent or fixed-term employment contract as well as pensioners/disability pensioners which remain in an employment relationship with the University regardless of the duration of employment;
- participants in full-time doctoral studies at the University of Warsaw, enrolled before the 2019/2020 academic year , and doctoral students studying at doctoral schools before they reach the age of 35, hereinafter referred to as "UW doctoral students".
