BICYCLE RENTAL RULES AND REGULATIONS

"Bajka" Holiday Home of the University of Warsaw

The present rules and regulations cover the terms of use, conditions, rights and responsibilities of persons using the bicycle rental service.

- 1. Bicycles available for rent are the property of the "Bajka" Holiday Home.
- 2. The bicycle rental is located in the facility's garage. It is open from 1 May 2023 to 31 October 2023, seven days a week, from 09:00 to 22:00.
- 3. The rented bicycle is technically sound and must be returned in the same condition.
- 4. In order to rent a bicycle, it is necessary read the Bicycle Rental Rules and Regulations and sign a consent form in the Rental Register agreeing to the terms and conditions contained in these Rules and Regulations. Bicycle rental shall only be available to the person being a Holiday Home guest.
- 5. A person under the age of 16 may only rent a bicycle upon the consent of an adult having the right of custody of the minor, who shall take full responsibility for the rented bicycle and the person using it.
- 6. The person renting a bicycle must not be under the influence of alcohol or other drugs, psychotropic substances or substitutes within the meaning of the regulations on counteracting drug addiction and other drugs, which by definition prohibit or recommend refraining from driving.

7. The Renter shall undertake to:

- use the bicycle and its equipment in accordance with its purpose;
- return the bicycle to the place where it was rented, i.e. the facility's garage, with its equipment in technically sound and undamaged condition;
- comply with the prohibition on lending the bicycle to third parties;
- secure it against theft using the cable lock and key provided in the event of leaving the bicycle outside the bicycle rental facility;

- immediately report any problems with the use of the bicycle to a facility employee and return the bicycle to the rental facility in case of discovering any damage to the bicycle while cycling;
- refrain from making any repairs, modifications or replacement of parts on the rented bicycle themselves;
- cover the costs of repairing the damaged bicycle or its equipment, resulting from the fault of the Renter;
- cover the purchase expenses of a new bicycle in the event of the complete destruction of the rented bicycle.
- 8. In the event of loss of the rented bicycle or its equipment due to circumstances which are the responsibility of the Renter, including theft or loss, the Renter shall reimburse the equivalent of the value of the bicycle and its equipment (based on prices valid on the market on the day of the discovery of this fact). Should the bicycle be stolen, the Renter shall be obliged to notify the Police and inform the Facility. The Renter shall agree to cover all damages and penalties related to the use of the bicycle resulting from non-observance of the legal regulations in force in Poland, including those resulting from the Traffic Code.
- 9. The Renter shall bear full responsibility for any accidents or damage occurring while using the rented bicycle. As a road user, the Renter shall be obliged to observe the principles of the traffic law and act solely at his/her own risk.
- 10. The bicycle user shall waive any claims against the Facility for accidents, damages or injuries occurring during the use of the rented bicycles.
- 11. The Renter shall bear sole responsibility for any damage caused to third parties in connection with the use of the rented bicycles.
- 12. It is forbidden to leave the bicycles on the premises of the Holiday Home.
- 13. Once the Renter has finished using the bike, he/she shall return it immediately to the bicycle rental facility.
- 14. The Renter shall comply with the provisions of the Rules and Regulations and use the bicycle in accordance with them.
