RESOLUTION NO. 6 OF THE RECTOR OF THE UNIVERSITY OF WARSAW

of 18 June 2025

on the amount of fees related to accommodation in the student halls of residence of the University of Warsaw in the 2025/2026 academic year

Pursuant to § 19, section 1 of the Rules and Regulations of the Student Halls of Residence at the University of Warsaw (UW Monitor of 2024, item 200), it is hereby resolved as follows:

§ 1

- 1. The amount of monthly fees for a place in the student dormitories of the University of Warsaw in the 2025/2026 academic year for students, doctoral students and participants of post-graduate studies at the University of Warsaw is specified in the appendix to this ordinance.
- 2. In the case of students and doctoral students of entities with which the University of Warsaw has concluded an agreement within the meaning of Article 43, section 1, point 30, letter c of the Act of 11 March 2004 on Goods and Services Tax (Journal of Laws of 2024, item 361, as amended), the amount specified in the appendix shall be increased by PLN 150.
- 3. In the case of persons other than those referred to in sections 1 and 2, the amount specified in the appendix shall be increased by PLN 150 and 8% VAT.
- 4. The fee for a child of a student or doctoral student who is under the age of 5 shall be charged at 50% of the amount specified in the appendix to this resolution.
- 5. In the case of a single person occupying a double room, the fee shall amount to 1.25 times the single room fee referred to in section 1. Conversion of a double room into a single room shall be permitted only if a sufficient number of vacant places is available.

§ 2

1. The amount of the reservation fee related to accommodation in the student halls of residence of the University of Warsaw for students, doctoral students, and participants of post-graduate studies at the University of Warsaw and their children, as well as for students and doctoral students of entities with which the University of Warsaw has concluded an agreement within the meaning of Article 43, section 1, point 30, letter c of the Act of 11 March 2004 on Goods and Services Tax, as well as for scholarship holders of the Polish National Agency for Academic

Exchange, shall be equal to the amount specified in the appendix to this resolution.

2. The amount of the reservation fee related to accommodation in the student halls of residence for persons other than those referred to in section 1 shall be equal to twice the amount specified in the appendix to this resolution.

§ 3

- 1. Upon a justified and documented request submitted by a person residing in a student dormitory, the Head of the Student Welfare and Support Office may grant a full or partial exemption from accommodation fees or allow the fees to be paid in instalments.
- 2. Grounds for exemption from the fee or for allowing payment in instalments may include, in particular:
- he status of a guardian of a person with a disability residing in the student hall of residence:
- 2) difficult financial situation of the student or doctoral student;
- 3) difficult personal circumstances of the student or doctoral student.
- 3. The applicant shall indicate whether they are applying for a full or partial exemption from fees, or for payment in instalments, the period for which the exemption is requested, and the student hall of residence in which they reside. In the case of a partial exemption request, the applicant shall also specify the amount of the reduction they are seeking.

§ 4

The resolution enters into force on the day it is signed.
