

## **BICYCLE RENTAL RULES AND REGULATIONS** **in the “WRZOS” Holiday Home of the University of Warsaw**

**The present Rules and Regulations cover the terms and conditions of use as well as rights and responsibilities of persons using the bicycle rental service.**

1. The rented bicycles (trekking bicycle, standard electric-assisted bicycle, tandem bicycle, youth bicycle, tricycle, Shoprider 4-wheeled scooter) constitute the property of the University of Warsaw.
2. The bicycle rental service at the “Wrzos” Holiday Home is open daily from 1 May to 30 September, from 9:00 to 21:00 (please contact the on-duty staff member).
3. The rented bicycle is technically sound and must be returned in the same condition.
4. In order to rent a bicycle, it shall be necessary read the Bicycle Rental Rules and Regulations and the Bicycle User Manual, then complete the bicycle rental form, attached as Appendix No. 1 to the Rules and Regulations, and sign a declaration agreeing to the terms and conditions contained in these Rules and Regulations. After the formalities are completed, the staff member shall provide the user with instructions on how to use the bicycle.
5. Only an adult guest of the “Wrzos” Holiday Home and shall be eligible to rent a bicycle.
6. For a person under the age of 18, a bicycle may only be rented by an adult, who takes full responsibility for the rented bicycle and the person using it. A necessary condition for persons aged 10 to 18 to use a rented bicycle is possession of a valid bicycle license.
7. The Renter shall be required to wear a protective helmet, appropriate footwear, and suitable clothing while riding.
8. The person renting a bicycle must not be under the influence of alcohol or other drugs, psychotropic substances or substitutes within the meaning of the regulations on counteracting drug addiction and other drugs, which by definition prohibit or recommend refraining from driving.
9. The Renter undertakes to:
  - use the bicycle and its equipment in accordance with its purpose;
  - return the bicycle to the place where it was rented together with its equipment in technically sound and undamaged condition;
  - comply with the prohibition on lending the bicycle to third parties;
  - secure it against theft using the provided cable lock and key in the event of leaving the bicycle outside the bicycle rental facility;
  - immediately report any problems with the use of the bicycle to one of the “Wrzos” employees and return the bicycle to the “Wrzos” in case of discovering any damage to the bicycle while cycling;
  - refrain from making any repairs, modifications or replacement of parts on the rented bicycle by themselves;

- cover the costs of repairing the damaged bicycle or its equipment, resulting from the fault of the Renter, based on the receipt or invoice from the repair shop;
  - cover the costs of replacing damaged or lost small parts (e.g., bell, cable lock with key) that do not require a visit to the repair shop, based on current market prices;
  - pay a fee of PLN 50 for each individual scratch on bicycle parts caused by the renter's fault - payable at the "Wrzos" Holiday Home, and to cover the cost of purchasing a new bicycle in the event of total destruction of the rented bicycle.
10. In the event of loss of the rented bicycle or its equipment due to circumstances which are the responsibility of the Renter, including theft or loss, the Renter shall reimburse the equivalent of the value of the bicycle and its equipment (based on prices valid on the market on the day of the discovery of this fact). Should the bicycle be stolen, the Renter shall be obliged to notify the Police and inform one of the "Wrzos" employees.
  11. The Renter shall agree to cover all damages and penalties related to the use of the bicycle resulting from non-observance of the legal regulations in force in Poland, including those resulting from the Traffic Code.
  12. The Renter shall bear full responsibility for any negative consequences of random events such as collisions, falls, fatigue, and resulting injuries to the Renter and third parties, as well as for any damages caused during the use of the rented bicycle. As a road user, the Renter shall be obliged to observe the principles of the traffic law and act solely at his/her own risk.
  13. The Renter acknowledges that riding a bicycle involves inherent risks, requires physical fitness and stamina, and may lead to stressful situations. The Renter shall waive any claims against the University of Warsaw for accidents, collisions, damages, or injuries sustained while using the bicycle.
  14. The Renter shall bear sole responsibility for any damage caused to third parties in connection with the use of the rented bicycles.
  15. It shall be prohibited to leave the bicycle on the premises of the "Wrzos" Holiday Home except in the designated rental area.
  16. Once the Renter has finished using the bike, he/she shall return it immediately to the bicycle rental facility for a formal handover.
  17. The Renter shall comply with the terms and conditions of these Rules and Regulations and use the bicycle in accordance with their provisions.
  18. Acceptance of the present Rules and Regulations and renting a bicycle shall be deemed equivalent to: a declaration of a state of health that allows for safe cycling; confirmation of the ability to ride a bicycle; possession of any permits required by law; and knowledge of traffic regulations.
